PET GOAT ADOPTION AGREEMENT

By signing this contract I agree to assume legal custody and financial responsibility of the described goat.

I fully understand and agree to the conditions of this adoption as follows:

1. I have read and understand the "Care for your pet goat" document provided by Pfaff Pfamily Pfarm and agree to provide the care and shelter requirements for the goat(s) being adopted. **Initial**
2. I hereby agree that the above described animal is being adopted by me solely as a pet for myself and/or my immediate family. I agree that I will not sell, give away or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute or any other entity for any reason.
3. If at a later date I am unable or unwilling to keep this pet, I agree to first contact Pfaff Pfamily Pfarm and give them the option to reclaim said pet at no charge.
4. I hereby agree to care for the above described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care.
5. I hereby agree that the **adoption fee of \$ _____** helps to cover the Pfaff Pfamily Pfarm expense of raising and caring for the animal and is not refundable after a trial period of 7 days.
6. I hereby understand and agree that the Pfaff Pfamily Pfarm makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that the current owner further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family.
7. The animal(s) will not be subjected to "common" livestock deformations such as: tail docking, ear tagging, branding, de-horning etc.
8. The animal(s) will not be utilized for any purpose to obtain money or profit. The animal(s) will not be exploited in my custody for monetary gain (exhibited or used for entertainment purposes such as, petting zoos, rodeos, a circus, etc.).
9. The animal(s) will not be denied regular veterinary care.
10. ALL babies must be vaccinated by 3 months of age and adopters must provide Pfaff Pfamily Pfarm with proof or validation from a veterinarian within 60 days after vaccinations are administered.
11. All males must be surgically castrated by the age of 3 months. This surgical castration method must include sedation or local anesthesia administered by a veterinarian
12. The custody of the animal(s) will not change unless Pfaff Pfamily Pfarm is notified and approves the change or transition of custody prior to the change.
13. You will notify Pfaff Pfamily Pfarm in the event of the following:
 - a. Any change in your address or residency.
 - b. At the time of the animal(s) death.
14. **The animal(s) will NEVER be used for meat, nor slaughtered.**
15. I agree to abide by additional conditions (if any are provided with this contract) and initial the conditions to confirm that I have agreed to them.

By signing this adoption contract I understand and accept the conditions of this agreement and recognize that Pfaff Pfamily Pfarm reserves the right to:

1. Check in" periodically by means of correspondence.
2. Conduct on-sight inspections of the animal(s) living conditions to assure that the animal(s) receives adequate food, quality healthcare, and appropriate and clean housing.
3. Nullify this contract and resume custody of adopted animal(s) immediately following any violation of this agreement.

In signing this contract, I promise to fulfill the expectations listed above and agree to these conditions.
